## Notice on Quarterly Results of TRLEI (Preliminary Report for 1<sup>st</sup> Quarter of Fiscal 2021)

The Universal Entertainment Corporation ("Company") hereby announces the results of Tiger Resort, Leisure & Entertainment, Inc. ("TRLEI"), the operating company for the "Okada Manila" integrated resort facility, for the first quarter of 2021 as follows.

Note that the disclosure of the Monthly Results of TRELI has been suspended as released in the "Notice on Temporary Suspension of TRLEI Monthly Results Disclosure" dated May 12, 2020, however, the Company has decided to restart the disclosure of TRLEI results in the form of quarterly preliminary report.

1. Quarterly Results (Summary)

TRLEI posted gross gaming revenue of 5,098 million Philippine pesos and other revenue of 188 million pesos for FY2021 1Q.

On year on year comparison, total revenue decreased by 42% (3,820 million pesos) to 5,286 million pesos and adjusted segment EBITDA decreased by 35% (377 million pesos) to 692 million pesos.
