Daikin Industries, Ltd. today announced that the changes in representative directors were determined at the Board of Directors' Meeting held on May 9, 2024. These appointments will become officially effective at the subsequent Board of Directors' Meeting, following the approval at the 121st Ordinary General Meeting of Shareholders to be held on June 27, 2024.

1. Reason for Change

Through the transition to a new structure in its centennial year of founding, Daikin aims for even greater speed in managerial decision-making and execution, amid significant changes in the environment surrounding the company group. In order to contribute to a sustainable society and achieve the group's growth, Daikin will reestablish the previously suspended COO position, taking on this challenge with all its strength. The person appointed as COO will have the company's representative rights, along with the CEO, and will focus on business execution as well as further enhancing the group management and governance.
