Notice Regarding Partial Amendment to Articles of Incorporation

We are pleased to announce that at today's Board of Directors meeting, it was resolved to propose an agenda item for the partial amendment of the Articles of Incorporation at the 56th Ordinary General Meeting of Shareholders scheduled to be held on June 26, 2024. Please find the details below.

1. Reason for Proposal of Agenda Item

- (1) The reason for proposing the agenda item is to amend the current purpose clause of the Articles of Incorporation to align with our current business activities and to add new business purposes to accommodate future business developments.
- (2) Prior to merging and absorbing our subsidiary to comprehensively succeed its operations, we are adding the objectives of the business to be succeeded in advance.
- (3) In addition to adding new business objectives, we are making formal changes such as renumbering to accommodate these additions.
