WELLNEO SUGAR Co., Ltd. (the "Company") hereby announces that at today's Board of Directors meeting, resolutions were made regarding the change of directors and executive officers of the Company effective June 26, 2024, and organizational structure as well as personnel changes of directors and executive officers of the Company, effective October 1, 2024, following the absorption-type merger with Nisshin Sugar Co., Ltd. and ITOCHU Sugar Co., Ltd., our wholly-owned subsidiaries, which will be dissolved (hereinafter referred to as the "Merger"). In addition, the organizational structure and personnel changes of directors and executive officers as of October 1 are subject to the approval of the absorption-type merger agreement at this General Meeting of Shareholders and the Merger taking effect in accordance with such merger agreement.


