Introduction of the Executive Officer System and Personnel Changes

At the Board of Directors meeting held today, our company resolved to introduce an Executive Officer System and implement personnel changes as described below.

- 1. Purpose of introducing the Executive Officer System

 The objective is to separate the decision-making and supervisory functions from the operational execution functions, thereby enhancing both. This aims to accelerate decision-making, improve operational efficiency, and strengthen corporate governance.
- 2. Overview of the Executive Officer System
- (1) The Executive Officers will be delegated officers.
- (2) The appointment and dismissal of Executive Officers will be decided by the Board of Directors upon consultation with the Nomination and Compensation Committee.
- (3) Directors may concurrently serve as Executive Officers.
- (4) The term of an Executive Officer will be within one year of appointment, with reappointment allowed.
- 3. Implementation date of the Executive Officer System June 24, 2024
