### Polaris Enters Business Alliance with Minacia Co., Ltd.

Polaris Holdings Co., Ltd. (hereinafter the "Polaris" or the "Company") announced today that the Board of Directors of Polaris resolved to execute a Business Alliance Agreement (hereinafter the "Agreement") with Godo Kaisha Corrida (hereinafter the "GK") and Minacia Co., Ltd. (hereinafter the "Minacia"). The agreement will help ensure that Polaris continues to build an industry best in class hotel operation, as well as maximizing corporate value and profits for both entities.

#### 1. Purpose of the Agreement

As stated in the "Polaris Makes Strategic Investment with Star Asia Group for the Acquisition of Minacia Co., Ltd." released on June 7, 2024, the Company executed a strategic joint investment with Star Asia Group in the GK established by Star Asia Group with the expectation that the considerable compatibilities between Polaris and Minacia will create synergistic effects through collaboration. The GK completed the acquisition of all shares of Minacia on the same day. Polaris executed the Agreement with the aim of building a stronger cooperative relationship and creating a platform that is among the best in the industry in terms of customer satisfaction, employee satisfaction, business efficiency, profitability, and growth rate, and to maximize the profits and corporate value of the contracting parties. With the execution of the Agreement, the Company and Minacia will further promote the implementation of a future management integration.

Minacia is a hotel operating company which operates 39 limited-service hotels totaling 5,180 rooms in key Japanese cities nationwide. Minacia operates under the Wing International brand, which has over 30-year history, and Tenza Hotel, which was launched in 2020. Both brands enjoy a high degree of recognition throughout Japan. Minacia also has a robust proprietary loyalty program that has a large number of repeating guests. Minacia also has extensive experience in the restaurant business and is developing restaurant concepts inside and outside of its hotels, taking advantage of specialized regional characteristics.

### 5. Overview of Star Asia Group

Star Asia is a privately owned, independent investment management group focused on delivering superior investment returns to its clients by investing primarily in Japanese real estate related opportunities. Star Asia Group has Star Asia Investment Corporation (Stock Code 3468) as its subsidiary.

Star Asia was co-founded in 2006 by Malcolm F. MacLean IV and Taro Masuyama who each have over 25 years of experience in real estate, credit, corporate finance, capital markets and securitization.

Since its inception, Star Asia has invested over JPY1.3 trillion (as of December 31, 2023) in real estate related opportunities including properties, loans, securitized assets, and companies. The Group's strong track record and long-term partnership approach with its investors have been integral in attracting significant capital from sophisticated global investors, including large U.S. university endowments and foundations, sovereign wealth funds, U.S. and Asia based family offices as well as other global real estate investors.
