We have decided to form a business alliance with Pacific Consultants Co., Ltd. as of today, and are pleased to announce the following.

### 1. Purpose of Business Alliance

- (1) OHBA and Pacific Consultants Co., Ltd. have a long history of working together on a variety of infrastructure projects to resolve social issues since our collaboration in reconstruction operations following the Great East Japan Earthquake.
- (2) We have concluded this business alliance with the aim of providing even more optimized services to address a diverse range of social issues, such as complex infrastructure projects, responding to intensifying natural disasters, and recovery and reconstruction projects, by mutually complementing and utilizing the technologies, knowledge, experience, and personnel systems possessed by both companies.

### 2. Scope of Alliance
