Notice Regarding Changes in Major Shareholders

ExaWizards Inc. hereby announces that, as of March 31, 2024, there has been a change in our major shareholder, including our principal shareholder, and they no longer qualify as major shareholders. We apologize for the delay in disclosing this information, which was due to inadequate verification, despite receiving the shareholder registry as of March 31, 2024, from our shareholder registry administrator, Mitsubishi UFJ Trust and Banking Corporation, on April 5, 2024.

1. Background

On April 5, 2024, We received the shareholder registry as of March 31, 2024, from Mitsubishi UFJ Trust and Banking Corporation. It was confirmed that there were changes in our major shareholder, including our principal shareholder, and they no longer qualify as major shareholders. This change occurred due to the exercise of stock options granted by the company, which increased the total number of voting rights among all shareholders and consequently reduced the percentage of total voting rights held by the shareholder listed below.
