Announcement Regarding the Status of Repurchase of Own Shares

(Repurchase of the Company's shares in accordance with the Articles of Incorporation under
Article 165, paragraph 2 of the Companies Act of Japan)

ITOCHU Corporation ("ITOCHU") decided at the meeting of the Board of Directors held on August 5, 2024 to repurchase own shares in accordance with Article 156 of the Companies Act of Japan, as applied pursuant to Paragraph 3, Article 165 of the Companies Act of Japan. ITOCHU hereby announces the status of the repurchase as follows.

1. Progress of the repurchase until December 31, 2024
 - (1) Type of shares repurchased: Common stock of ITOCHU
 - (2) Total number of shares repurchased: 4,082,100 shares
 - (3) Total amount: 31,252,584,500 yen
 - (4) Period: From December 1, 2024 to December 31, 2024
2. Accumulated total of the repurchase until December 31, 2024 pursuant to the above resolution
 - (1) Total number of shares repurchased: 18,445,300 shares
 - (2) Total amount of shares repurchased: 139,047,794,500 yen
