### **Kikkoman Announces Status and Conclusion of Acquisition of Own Shares**

(Under the provisions of Kikkoman's Articles of Incorporation pursuant to Article 165-2 of the Companies Act of Japan)

Kikkoman Corporation ("the Company") announces that it has executed to acquire its own shares under Article 156 of the Companies Act of Japan, as applied pursuant to Article 165-3 of the Companies Act. The details of the share acquisition for February 2025 are as follows.

This concluded the acquisition of own shares in accordance with the resolution of the Board of Directors meeting held on October 25, 2024.
