## Notice Regarding Change of Registered Name and Status of a Subsidiary

Sumitomo Forestry Co., Ltd. (hereinafter, Sumitomo Forestry) announced in the "Notice Regarding the Reorganization and Registered Name Change of a Subsidiary" released on March 28, 2025, that the registered name of consolidated subsidiary Brightland Homes, Ltd. would be changed to Brightland Homes, LLC. However, following a review of our brand strategy, we hereby announce that we have decided to change the registered name of this company to DRB Group Texas, LLC.

Furthermore, we have decided to remove this company from the "Status of Subsidiaries and Affiliates" section of our Annual Securities Report. This change constitutes a change in subsidiary status, etc., as defined under the timely disclosure rules. Please note that there will be no change in the capital relationship and the subsidiary will remain a consolidated subsidiary even after the status change.
