Tokyo Hakuzen Expands Funeral Hall Facilities at the Kirigaya Funeral Home, Enhancing the Convenience of the Integrated Funeral and Cremation Complex Available from December 12, 2025

The expanded funeral hall at the Kirigaya Funeral Home (Shinagawa, Tokyo), operated by Tokyo Hakuzen Co., Ltd. (Minato City, Tokyo; President and Representative Director: Ryoma Noguchi; hereinafter "Tokyo Hakuzen"), a member of the Kosaido Group, has been completed and became available for use starting with the evening service on Friday, December 12, 2025.

■ Background

Tokyo Hakuzen is working to enhance the convenience and quality of its services in response to the increasingly diverse funeral needs in urban areas and the rising number of funeral services. In the Kosaido Group's Medium-Term Business Plan 5.0, strengthening the functions of existing funeral homes is positioned as a key initiative in the Group's growth strategy. The expansion of the funeral hall was carried out as part of these efforts, with the aim of further improving the convenience and added value of the integrated funeral and cremation complex.

■ Initiative Overview and Future Plans

Tokyo Hakuzen currently operates and owns 69 funeral halls across Tokyo's 23 wards. With the addition of five new halls at the Kirigaya Funeral Home through this expansion project, the total number has increased to 74.

Looking ahead, Tokyo Hakuzen plans to complete the addition of 10 new halls at the Yotsugi Funeral Home (Katsushika City, Tokyo) in June 2026.

To help resolve issues such as cremation delays caused by a shortage of funeral hall capacity, the company will continue to consider further expansions at other facilities.

■ Details of the Expanded Funeral Hall

• Hall name: "Lotus (Hasu)"

• Capacity: Small groups up to 24 attendees

• Features:

The hall is designed for small-scale funerals and integrates the funeral space and waiting room into a single, unified layout. For the newly added "Hasu" hall, an entrance reception area (foyer) has been newly installed to welcome attendees, creating a greater sense of privacy.
