Notification regarding the status and conclusion of repurchase of shares of common stock

Tokyo, December 19, 2025 Hitachi, Ltd. (TSE:6501) today announced the status of repurchase of its own common stock pursuant to Article 459, Paragraph 1 of the Companies Act of Japan and Article 32 of Hitachi's Articles of Incorporation, which was approved at the Board of Directors meeting held on April 28, 2025, as follows.

This concludes Hitachi's repurchase of shares of its own common stock approved at the Board of Directors meeting.
