(the "Company") hereby announces that, effective February 1, 2026, it has decided to transfer the business related to the operation of AUTOBACS stores in Iwate, Akita, Miyagi, and Fukushima Prefectures from its consolidated subsidiary, AUTOBACS Higashi-Nihon Sales Ltd. (hereinafter "AUTOBACS Higashi-Nihon Sales"), to its wholly owned subsidiary, AUTOBACS Kanto Sales Ltd. (hereinafter "AUTOBACS Kanto Sales"), which was established on November 6, 2025. The transfer will be implemented through an absorption-type company split (hereinafter the "Company Split"). AUTOBACS Kanto Sales will commence operations following the Company Split.

As the Company Split will be carried out between the Company's consolidated subsidiaries, certain disclosure items and details have been omitted.
