In connection with this transaction, the Company entered into a share purchase agreement on December 16, 2025, and SA acquired all shares of PY on January 15, 2026. As a result of SA’s acquisition of all shares of PY and the acquisition of shares of PY’s subsidiaries, the six subsidiaries of PY also became wholly owned subsidiaries of the Company. In addition, PY and its subsidiary CULTIVOS YADRAN S.A. fall under the category of specified subsidiaries of the Company.
