Notice of Changes to Organization and Personnel Changes

At the Board of Directors meeting held on February 27, 2019, the Company made decisions on organizational changes and personnel changes, as described below.

Particulars

1. Changes to organization (as of April 1, 2019)

With the aims of enhancing governance structure which forms the foundation for the promotion of growth strategy and improving the productivity of back office departments, the following organizational changes will be made in the General Administration Division to strengthen cross-departmental collaboration.

- (1) Finance & Accounting Department, which currently reports directly to the president, will be placed under the management of General Administration Division.
- (2) Global Quality & Procurement Division will be abolished, Quality Assurance Department and Procurement Department will be established both under the management of General Administration Division.
- (3) BPR Promotion Department will be established in order to promote company-wide productivity improvement activities linked to management goals.
- (4) The Japanese term for department used in Corporate Relations Department, Legal Department, General Affairs & Personnel Affairs Department and Information System Department will be revised.


