The two Outside Director candidates meet the requirements set by DeNA for independence. If they are appointed as planned, one third or more of directors will be Independent Outside Directors.

DeNA plans to register Mr. Koji Funatsu and Mr. Hiroyasu Asami as Independent Directors as defined by Tokyo Stock Exchange, Inc. In the event that Mr. Koji Funatsu is reappointed as Director, and Mr. Hiroyasu Asami is appointed as Director, the Company intends to register them as Independent Directors as defined by the Tokyo Stock Exchange, Inc. 
